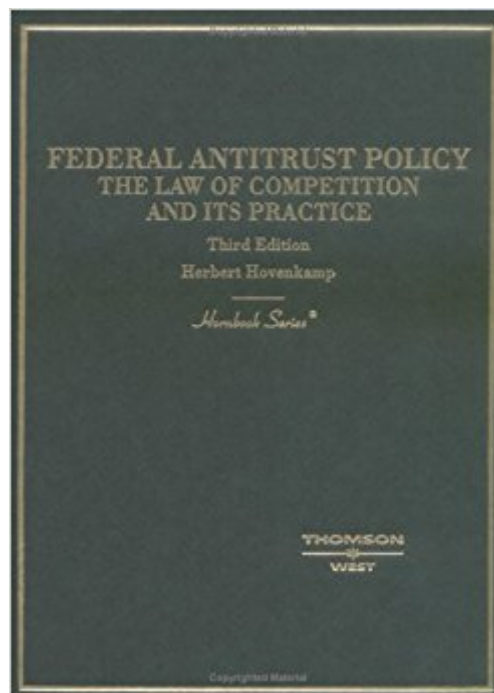

Hornbooks are valuable assets to law students. The usual practice at Law School is to use a Casebook, which contains summations of major cases. The student then "briefs" that case by summing up the major points of law used to determine the ruling in that particular case.
