

The electronic version of the FAR/AIM requires an Adobe application to read, you cannot read it in iBooks (for example). An Adobe application (free) must be installed on your device (in our case Mac and iPad) to read the AIM/FAR. Makes it a bit more awkward, as I cannot organize it with other flying documents for easy access, and eats that much more memory on the device.

FAR/AIM is required for flying safely and legally. It is available on-line but I prefer to read the written page.
