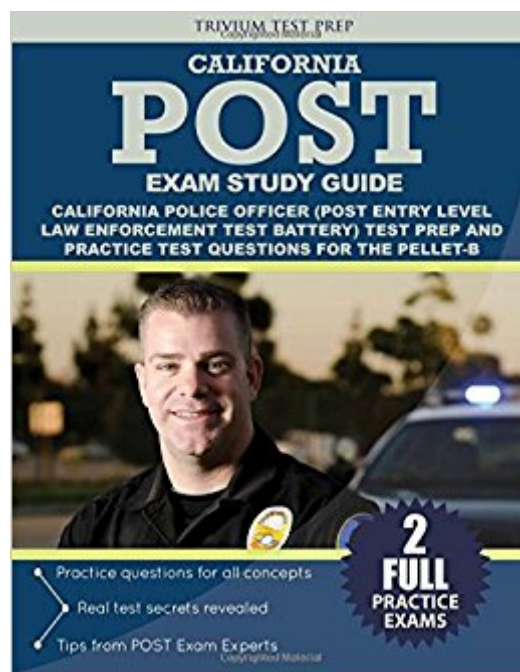

Using this book, I was able to get a t-score of mid-60's while taking the test in a room full of college grads. -1 star because it provides no scoring rubric. I found that I averaged around a 70% traditional score on the practice tests, which put me in the t-score range of 60's.
